Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do and don't do.	
What?	The types of personal information we collect and may share depend on the financial	
	services you receive from us. This information can include:	
	 Social Security number and contact information; 	
	Account balances and transaction history; and	
	Sources and amounts of income.	
How?	All financial companies need to share clients' personal information to run their

Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Marble Trail Financial, a provider of tax and accounting services, is our sole "affiliate."		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Examples include custodians and various providers of technology solutions, including Envestnet/Tamarac and Morningstar/Redtail.
